

INTERNAL RULES OF THE L'ORGATTE MUNICIPAL CAMPSITE:

ADMISSION CONDITIONS : To be allowed to enter, settle in, and stay on the Orgatte campground, you must have been authorized to do so by the manager or his representative, who is responsible for ensuring the good keeping, safety and order of the campground, as well as compliance with the application of these internal regulations.

Staying on the campsite implies acceptance of the provisions of these regulations and the undertaking to comply with them.

POLICE FORMALITIES : Anyone who is planning to stay at least one night in the campground must first present identification to the manager or his representative.

Minors who are not accompanied by their parents will not be admitted.

INSTALLATION : The tent or trailer and related equipment must be set up at the location indicated, as directed by the manager or designate. Only one installation per site will be permitted.

EQUIPMENT LOAN: A security deposit will be required when lending equipment (subject to availability).

RECEPTION DESK : Opening hours are posted at the entrance. At the reception desk, you will find all the information on the campsite's services, information on the possibilities of refuelling, sports facilities, the tourist attractions of the surrounding area and various addresses that may be useful (doctors, hospital, nurses, etc.).

A complaint book is available at the reception desk and is available to users. Claims will only be considered if they are signed, dated and as accurate as possible, reporting relatively recent events.

FINANCIAL CONDITIONS – FEES: Camping services will be invoiced according to the current rate displayed at the entrance and at the reception desk. The amount due will be based on the number of nights. For reservations, the payment of the price of the stay must be paid in full on arrival at the campsite.

Tourist taxes instituted by the Community of Municipalities are not included in our rates. They are collected per day, and per person under 18 years of age, and paid with the payment of the stay. Our prices include VAT

NOISE AND SILENCE : Campground users are urged to avoid noise and discussion that could disturb their neighbours. Sound devices must be adjusted accordingly. Door and trunk locks should be as discreet as possible. There should be total silence between 11 p.m. and 7 a.m.

ANIMALS:

In accordance with Article 211-1 of the Rural Code and the implementing decrees and ministerial orders, 1st and 2nd category dogs are prohibited.

Dogs and other animals must not be allowed to roam free, or even locked up on the campsite, in the absence of their owners who are civilly responsible for them.

Only a maximum of 2 pets will be allowed per pitch.

At the entrance of the establishment, the vaccination card will BE MANDATORY. Category one and category two dogs are not allowed.

VISITORS : After being authorized by the manager or his/her representative, visitors may be admitted to the campground under the responsibility of the campers who receive them. They must, without exception, go to the reception desk upon arrival to register and pay the current rate. This fee is posted at the entrance to the campground and at the reception desk. If they want to stay overnight, we ask you to declare them as an extra person at the reception desk when they arrive at the campsite.

TRAFFIC AND PARKING OF VEHICLES : When you arrive, park in the car park located at its entrance. Inside the campground, vehicles must travel at a speed limit of 10 km/h. Traffic is prohibited between 11 p.m. and 7 a.m.

Only vehicles belonging to the campgrounds may be used on the campground. It is strictly forbidden to park in neighbouring spaces, nor to impede traffic in the alleys, nor to prevent the installation of new arrivals. The pitches have space for their vehicles. Any additional vehicles must be parked in the car park at the entrance to the campsite.

DRESS AND APPEARANCE OF FACILITIES: Everyone is required to refrain from any action that could adversely affect the cleanliness, hygiene and appearance of the campground and its facilities, including sanitary facilities. It is forbidden to dispose of sewage on the ground or in the gutters.

"Caravanners" are required to empty their waste water in the facilities provided for this purpose. Washing is strictly forbidden outside the bins provided for this purpose. Laundry hanging will be done in a discreet manner and not disturbing to the neighbors. Under no circumstances should wires be connected to trees to serve as drying racks. Plantings and floral decorations must be respected.

It is mandatory for campsite users to put their rubbish in garbage bags before disposing of it in the containers provided for this purpose and located in the campsite's outdoor car park.

In the name of recycling, we kindly ask you to sort glass and plastic, no personal outdoor bins will be allowed on the personal site for obvious hygiene reasons.

Campers are forbidden to drive nails into trees, cut branches, make plantings. It is also not permitted to demarcate the location of a facility by personal means, nor to dig the ground. Any damage to the vegetation, fences, land or facilities of the campground will be the responsibility of the perpetrator.

The pitch, which will have been used during the stay, must be maintained in the condition in which the camper found it when entering the premises.

SECURITY :

Fire : The use of wood, coal, gas barbecues and fires on the ground are PROHIBITED. Only electric barbecues are allowed.

Stoves must be kept in good working order and not used in hazardous conditions. In the event of a fire, immediately notify management and follow the safety instructions posted in the washrooms and at the reception desk.

Fire extinguishers can be used if necessary. A first aid kit is available at the reception desk.

Liability, Theft : The general obligation to supervise the campground is an obligation of means. The Management cannot be held liable in the event of theft, loss or damage of any kind, during or following a stay. Although security is provided, campground users are invited to take the usual precautions to safeguard their equipment. The camper remains responsible for his/her own installation and must report to the person in charge the presence of any suspicious person.

The campsite declines all responsibility in the event of trees or pine cones falling on equipment and vehicles.

GAMES : No violent or disturbing games may be organized in the vicinity of the facilities or on the playgrounds or sports areas.

DEAD GARAGE : Unoccupied equipment may only be left on the land with the agreement of the management and only in the indicated location, subject to the current fee.

There will be no dead garages during the months of July and August.

SIGNAGE : These house rules are posted at the entrance to the campground and at the reception desk. It will be given to the customer at their request.

VIOLATION OF THE HOUSE RULES : In the event that a tenant disturbs the stay of other users or does not comply with the provisions of these house rules, the manager or his representative may, orally or in writing if he deems it necessary, give notice to the latter to cease the disturbances. In the event of a serious or repeated breach of the internal rules and after formal notice by the manager to comply with them, the latter may terminate the contract resulting in the immediate departure of the tenant without any compensation. In the event of a criminal offence, the manager may call on the police.

SPECIAL CONDITIONS:

In accordance with the regulations in force, the L'Orgote campsite is a tourist establishment whose exclusive purpose is to welcome campers using, as part of their leisure activities and on a temporary basis, a camping shelter consisting of a tent, a caravan or a motorhome. Access to the land is therefore prohibited to any person using one of these shelters, either as a means of permanent or long-term accommodation, or for commercial purposes. Similarly, users of the land are prohibited from engaging in any act of commerce or commercial advertising on the land.

Access is forbidden to street vendors, canvassers, walkers, picnickers and non-campers.

It is forbidden to play ball in the alleys of the campsite because of the risk of fire that could result, misaligned satellite dishes, broken tiles...

Washing clothes and dishes is prohibited after 10 p.m. and before 8 a.m.

Showers and sinks will be closed after 10:30 p.m.

Children's playgrounds open from 9:30 a.m. to 10 p.m.

The campsite gates open at 7 a.m. and close at 11 p.m. from July 1 to August 31.

Barbecues must be switched off by 9:45 pm – only electric and gas barbecues are allowed

Stays made per booking are payable on arrival.

Visitors staying for more than 4 hours must go to the reception and pay the amount according to the current rate per person payable at the campsite reception.
